

**MEMORANDUM OF ASSOCIATION**

**COMPANY LIMITED BY SHARES**  
**(Incorporated under the Companies Act, 1956)**

- I. The name of the Company is RADAAN MEDIAWORKS INDIA LIMITED
- II. The Registered Office of the Company will be situated in the State of Tamil Nadu
- III. The objects for which the Company is established are:

**(A) MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:**

- 1. To undertake in India and abroad production of Tele-Films, Tele Series, Motion Pictures and such other Productions of similar nature.
- 2. To undertake in India and abroad activities allied to Post Production of Films such as Editing, dubbing, Tele Cine Conversion and other similar activities.
- 3. To undertake in India and abroad creation of Software and other Computer related applications for Film Production and other related activities.
- 4. To trade, market, lease, supply, distribute, buy, sell, import, export Films, Rights on Films, Tele Films, Tele Serials, Software on Films and other related Products.
- 5. To let on lease or otherwise, Studios, Assets, Equipments for production of Films and other related activities.
- 6. To acquire or setup and have Training institutions in India and abroad to educate and train on Film Production and other related activities.

**(B) OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE ABOVE MAIN OBJECTS ARE:**

- 1. To enter into agreements and contracts with Indian or foreign individuals, companies or other organizations for technical, financial or any other assistance for carrying out all or any of the objects of the Company.
- 2. To advertise, exhibit, broadcast and adopt other means of making known the business activities of the Company as may be expedient including posting of bills in relation thereto and the issue of circulars, books, pamphlets and pricelists and the conducting of competitions, exhibitions, demonstrations and the giving of prizes, rewards and donations.

3. To apply for, purchase or otherwise acquire and protect, prolong and renew trade marks, trade names, designs, secret processes, patents, patent rights, brevets, inventions, licences, protections and concessions which may appear likely to be advantageous or useful to the Company and to spend money in experimenting and testing and improving or seeking to improve any patents, inventions or rights, which the Company may acquire or propose to acquire or develop.
4. To enter into partnership or into any arrangement for sharing profits, union of interest, co-operation, joint venture, reciprocal concessions or otherwise with any person, firm or company carrying on or engage, in or about to carry on or engaged in any business or transaction which the Company is authorized to carry on and to lend money, to guarantee the contracts or otherwise acquire and to sell, hold, reissue with or without guarantee or otherwise deal with such shares and securities.
5. To enter into any arrangement with any Government or State Authority, Municipal, Local or otherwise that may seem conducive to the Company's objects or any of them and to obtain from any such Government or State authority, any rights, privileges and concessions which may seem conducive to the Company's objects or any of them.
6. To apply for, tender, purchase or otherwise acquire any contracts and concessions for or in relation to the construction, erection, equipment, improvement, management, administration, or control of works and conveniences and to undertake, execute, carry out, dispose of or otherwise turn to account the same.
7. To buy, obtain on lease, exchange, hire or otherwise acquire lands, buildings and other immovable properties and to sell, lease, mortgage, or hypothecate or otherwise dispose of all or any of the properties and the assets of the Company on such terms and conditions as the Company may think fit.
8. To purchase, takeover on lease or otherwise, merge or otherwise acquire the whole or any part of undertaking, Business, Goodwill, any Movable property any Rights, Liabilities and Assets of any Person, Firm, Association, Company, whether within or outside the Group Organisation of any Form, which the Company may think necessary for the purpose of Business.
9. To pay all the costs, charges and expenses of and incidental to the promotion and formation, registration and establishment of the Company and issue of its capital including any underwriting or other commission, broker's fee and charges in connection therewith including costs, charges, expenses of negotiations and contracts and arrangements made prior to and in anticipation of the formation and incorporation of the Company.
10. To remunerate, by cash or other assets or by the allotment of fully or partly paid shares or by call or option on shares, debentures, debenture stocks or securities of this or any other company or in any other manner whether out of the Company's capital, profits, or otherwise to any person or firm or company for services rendered or to be rendered in introducing any property or business to the Company or placing or assisting to place or guaranteeing the subscription of any shares, debentures, debenture stock or other securities of the Company or for any other reason which the Company may think fit.

11. To undertake and execute any trusts, the undertaking whereof may seem desirable either gratuitously or otherwise.
12. To draw, make, issue, accept, endorse, discount and negotiate promissory notes, hundies, bills of exchange, bills of lading, delivery orders, warrants, warehouse keeper's certificates and other negotiable or commercial or mercantile instruments connected with the business of the Company.
13. To open accounts with any individual, firm or company or with any bank or banks and to pay into and to withdraw moneys from such account or accounts.
14. To lend or deposit moneys belonging to or entrusted to or at the disposal of the Company to such person or company and in particular to customers and others having dealings with the Company with or without security, upon terms as may be thought proper and guarantee the performance of contracts by such person or company.
15. To borrow or raise money with or without security to receive money on deposit at interest or otherwise in such manner as the Company may think fit and in particular by the issue of debentures or debenture-stock perpetual or otherwise including debentures or debenture-stock convertible into shares of this or any other company and the security of any such money so borrowed, raised or received to mortgage, pledge or charge the whole or any part of the properties, assets or revenue of the Company present or future, including its uncalled capital and to purchase, redeem, or pay off any such securities. But the Company shall not carry on any Banking Business.
16. To make advance upon or for the purchase of Tickets, booking of accommodations, transporting vehicles, hiring Halls, land and Buildings, Materials, goods, Machinery, Equipments, stores and other articles or services required for the purpose of the Company.
17. To sell, mortgage, assign or lease and in any other manner deal with or dispose of the undertakings or properties of the Company or any part thereof, whether movable or immovable for such considerations as the Company may think fit and in particular for shares, debentures or other securities of any other company having objects altogether or in part similar to those of this Company.
18. To improve, manage, work, develop, alter, exchange, mortgage, lease, turn to account, abandon or otherwise to deal with all or any part of the properties, rights and concessions of the Company.
19. To provide for the welfare of the employees or ex-employees of the company and wives, widows, families or dependents or connections of such persons by building or contributing to the building of houses, dwellings or by grant of money, pensions, gratuity, bonus, payment towards insurance or other payment; or by creating from time to time, subscribing or contributing to adding or supporting provident funds or trust or conveniences and by providing or subscribing or contributing towards places of instruction, or recreation, hospitals and dispensaries, medical and other assistance as the Company shall think fit.
20. To subscribe or contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national or other institutions or subjects or any public or general or useful objects.

21. To distribute any of the properties of the Company amongst the members in specie or kind upon the winding up of the company.
22. To give any guarantee or indemnity for the payment or the performance of any obligation or undertaking.
23. To employ experts to investigate and examine into the condition, prospects, value, character and circumstances of any business concerns and undertaking and generally of any assets, property or rights.
24. To promote similar company or to take part in the formation or management of similar company or undertaking and to appoint and remunerate any accountants or experts or agents.
25. To give any guarantee in relation to the payment of any debentures debenture-stock, bonds, obligations or securities and to guarantee the payment of interest thereon or of dividends on any stock or shares of the Company.
26. To receive, hold and take charge of monies lodged as margins on commercial operations.
27. To manage land, buildings and other properties both movable and immovable whether belonging to the Company or not and to collect rents and income and to supply to tenants and occupiers, attendants, servants, waiting rooms, reading rooms and other conveniences.
28. To obtain any provisional order or Act of the Government for enabling the Company to carry on any of its objects into effect and for giving effect to any modification of the Company's constitution.

**(C) OTHER OBJECTS:**

1. To buy, sell, import, export, manufacture or to act as agents or otherwise deal in Computers, Typewriters, all electronic equipments, Cinematography Equipments, cleaners, sewing and printing Machines, air-conditioning equipments, air conditioners, refrigerators, coolers, ice-cream manufacturing machinery, medical, surgical, scanning and the like equipments.
2. To carry on the profession of consultants on management, employment, engineering, medical, surgical, industrial and technical matters relating to industry and business.
3. To carry on the business of printing and publishing books, magazines, journals, Periodicals and newspapers and to act as agents in connection therewith.
4. To carry on the Business of Advertising Contractors and Agents, to acquire and dispose of Advertising time, space or opportunities in any form of Media, to undertake advertising and promotional campaigns of every nature.

5. To develop, implement, trade, manufacture, convert, alter, modify, import, export, purchase, sell, lease or deal in Software, and hardware of every nature and to act as consultants, institutionalists regarding therewith.
6. To carry on the business of Construction of Buildings of all nature including construction of Film Studios of all nature and to act as Consultants.
7. To carry on in any form or manner or be associated with the business of general traders and merchants, importers, and exporters, agents, representatives and dealers in and chemicals, and spirits, acids, glass, textiles, wearing apparels, papers, cloth, wood, cement, ceramics, salts, electricals and electronic products, equipments and instruments, fans, refrigerators, air-conditioners, heaters and coolers, jewel, gems and precious or semiprecious stones and ornaments, pumps, electrical motors, generators, batteries, dynamos, electrical, mechanical and scientific apparatus and instruments, plant and machinery, oils, paints, varnishes, waterproof materials, oil cloth, tarpaulin, linoleum, food stuffs and provisions, plastics and plastic goods, polyethylene products, electrical goods, cinematograph and photographic materials, weighing and measuring machines, domestic appliances, furniture, novelties, ceramics, ivory, watches, clocks and timepieces, typewriters and other office equipments, cotton, silk, jute, wool, rayon, nylon, polyester and other synthetic materials, carpets, toys, radios, radiograms, sound recorders, and reproducers, television, crockery, cutlery, glass, china hardware, petrol, fuel and generally to deal in any other commodities, substances, articles, merchandise, goods and things whether liquid or solid or gaseous stage either as merchants, dealers, traders, assemblers, packers, stockists, wholesalers, retailers, commission agents, brokers, adatyas, muccadams, repairers, fitters, and servicers, importers and exporters, representatives or otherwise in any other capacity.
